#### Product

Paper is made of virgin fibres and bleached according to ECF.

# **Packaging**

PE foil is made by refining of mineral oil or natural gas. The polymer consists simply of carbon and hydrogen. The corrugated board box is to a large extend made of recycled fibres. The printing ink is water-based.

## **Product Safety**

The product/raw materials fulfill the following:

- EU Regulation 1935/2004/EC on materials and articles intended to come into contact with food.
- EU Regulation 2023/2006/EC on good manufacturing practice for materials and articles intended to come into contact with food.
- BfR XXXVI. BfR Bundesinstitut für Risikobewertung.
- LFGB (Lebensmittel- und Futtermittelgesetzbuch, Germany Regulation).

- The printing inks fulfil BgVV, Empfehlungen des Bundesinstitutes für gesundheitlichen Verbraucherschutz und Veterinärmedizin, Part C Bedarfsgegenständeverordnung § 3 Anlage 1 Nr.
  7. Azo dyestuffs that may split in carcinogenic amines are not used.
- The dyes do not contain heavy metals such as mercury, cadmium and lead or hexavalent chromium.
- Dyes and printing inks are tested according to EN 646 (Determination of colorfastness of dyed paper and board) and has been found to have good fastness.
- Duni manufacturing units are certified according to the international quality system ISO 9001. They have also implemented the environmental management system ISO 14001.

## Management of used products

#### **Energy Recovery**

All the materials are suited for energy recovery. Complete combustion gives mainly rise to carbon dioxide and water. The energy content of plastics/paper is comparable to that of oil/ wood.

# Recycling

Recycling of the plastic and the corrugated board is possible for producing new products. Check with the local recycling company.
