### Material

PET (Polyethylene terephthalate) made from 80 % post-consumer recycled PET and 20 % virgin PET

# Packaging

Inner: PE Outer: Carton

### Field Of Application

The Polardeli boxes bring a fresh perspective to mindful packaging design. Ideal for delis, they protect chilled food while their transparent boxes and lids with their antifog feature make it look delicious.

The trays can be used safely with all types of foods, serving cold and warm up to 70°C for maximum 2 hours. Be aware at temperatures close to 70°C the sturdiness of the plastic is affected and may deform.

The product is not suitable for heating in microwave oven.

The articles can be used for long term storage in ambient and chilled conditions.

### EC Directive 94/62/EC on Packaging and Packaging Waste

The packaging complies with all essential requirements as defined by 94/62/EC. For example minimum adequate amount of packaging, limitation of heavy metal content, recyclable through at least one of the following: reuse, material recovery, energy recovery or composting.

### **Environmental Aspects**

<u>Product</u>

The product consists of 80 % PCR PET (Post Consumer Recycled).

Recycled PET is a fossil-based plastic that comes from recycled PET bottles. The plastic is treated in a process that makes the recycled plastic approved for food contact use.

Choose RPET to promote a circular economy where materials are used again at high value.

### <u>Packaging</u>

PE is manufactured from mineral oil or natural gas.

The corrugated board is unbleached and to a large extent made from recycled fibres.

### **Product Safety**

The products fulfill the following:

# End of Life

#### Recycling

RPET can be recycled with the same collection and recycling stream as PET.

Recycling of the plastic- and the corrugated board packaging material is possible for producing new products. Check with the local recycling company.

Collection, sorting and material recovery are all part of the recycling process. Recycling is dependent on local waste handling infrastructure. Ease and recyclability of a product depends on the type of material, composition and sometimes colour. Check with local waste handling to get the correct information.

### Energy Recovery

Incineration of mixed waste for energy recovery is a good end-use of products. Paper and plastic may burn well with low emissions.

Incineration facilities for energy recovery are dependent on local infrastructure. Incineration for energy recovery is a good alternative when material recovery is not available by recycling.

### Validity

This is issued 2023-07-06. It is revised when there is a change in the manufacturing process, in the product or in legislation.
