Product Identification and Traceability

This Declaration of Conformity applies to the product identified by the Duni article number stated in this document. The article number can be verified and traced through the EAN/GTIN code displayed on both the consumer packaging (CU) and the SKU transport packaging, where applicable.

For Duni products, the six digits immediately preceding the final check digit in the EAN code correspond to the Duni article number. The final digit of the EAN code is a check digit used for code validation and does not form part of the article number.

The article number shown in this Declaration of Conformity therefore provides a direct link to the EAN code printed on the product packaging and transport packaging, enabling product identification and traceability throughout the supply chain. This traceability system supports the identification of the packaging covered by this Declaration and the associated technical documentation. Based on Duni's existing PPWR traceability approach, identification elements are used to support the traceability requirements under Article 15 of Regulation (EU) 2025/40.

Supporting technical documentation

Compliance with this Declaration is supported by technical documentation prepared and maintained separately from the Declaration of Conformity. The technical documentation contains the evidence necessary to demonstrate compliance with the applicable requirements of Regulation (EU) 2025/40, including, where relevant, material specifications, supplier declarations, test reports, calculations, risk assessments, and other assessment records.
